Terms are as follows;

[YES] Can sell personal rights directly to the end user.

[YES] Can be added to paid membership sites that charge \$7+/month. You can provide your members with master resell rights, but not branding rights.

[YES] Can add your name to the sales letter and completely edit it (recommended).

[YES] Can add unlimited number of bonuses to the offer so long as the product remains the main selling point.

[YES] Can bundle up to 2 products from RRVIDS.com together and charge the suggested minimum price.
